The objects of the Trust are:

- Education to all.

- Grant, adhoc or annual financial assistance to educational institutions, institute scholarships, prizes, medals, rewards and endowments for excellence in studies and scientific research, grant of tuition fees and pecuniary assistance for distribution of books, stationery, food, free of cost or at concessional rates to poor and deserving boys, girls to prosecute educational courses in India and /or abroad and;
- Establishment of Kalyana Mantapa, Choultries, Temples, Cultural institutions and maintenance of the same.
- To print, publish, exhibit and sell books, magazines, periodicals helpful to its activities in achieving its objects.
- To construct and maintain buildings including rights to alter or improve them suitably, to acquire to receive and hold property of any kind i.e., movable and immovable as permissible under law.
- The trust shall undertake all such other activities that will be conducive for the achievement of the above aims and objects.

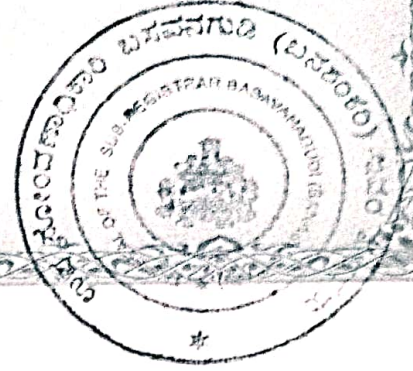

BENEFICIARIES OF THE TRUST:

PROPERTIES OF THE TRUST:

The properties of the trust shall be:

- The sum of Rs. 10,000/- (Rupees Ten Thousands only) above referred to;
- Any properties, moveable, immovable, that may be acquired by purchase or otherwise all rights, title or interest in or over any properties moveable or immovable that may be acquired by the purchase or otherwise.
- All additional and accretions to the trust properties; and
- All voluntary donations, Gifts, legacies or grant in cash or in kind accepted by the trustees, upon trust for the objects set out herein above and subject to the provisions and conditions hereinafter contained in these presents.

NUMBER OF TRUSTEES AND THEIR TERM AND POWER TO CO-OPT:

There shall be not less than 5(Five) trustees and not more than 9(Nine) trustees. The first Trustee i.e., the parties of the second part, shall hold the office in the following:

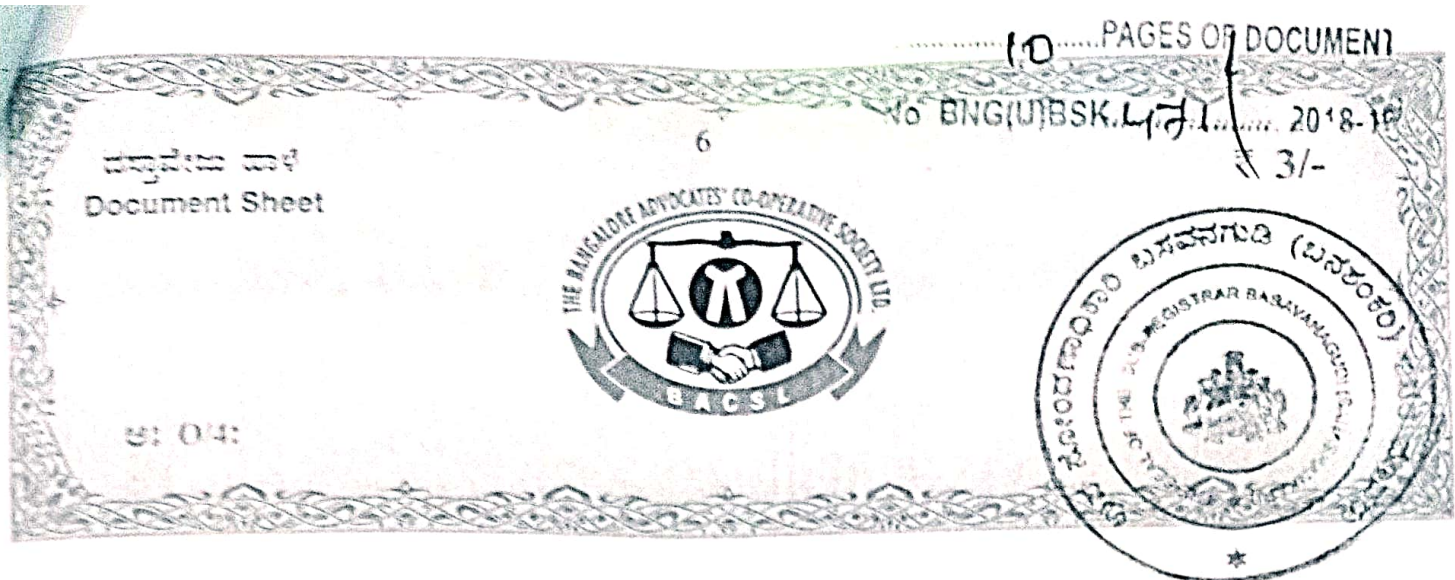

Note: Trust has power to invite not more than **3(Three)** permanent invitees.

The term of office of the trustees shall be for a period of their life. The first Managing Trustee and the Founder Chairman shall have the power to fill in any vacancies arising in any manner whatsoever in the office of the Trustees, and he shall in addition also have the power to nominate any person as additional trustee, so that the number of trustees at any time shall not exceed **Nine**. After the life time of the First Managing trustee the vacancies arising by death, resignation, retirement or otherwise, may be filled up by co-option by the continuing trustee or trustees, as the case may be. If there are no trustee functioning at any time, the trustees shall be appointed in accordance with law by a Court of competent jurisdiction. Every trustee so co-opted or appointed will have the same powers and rights as if he or she was originally appointed as a trustee under these presents.

In the event of any necessity, the total strength of the Board of Trustees may be increased beyond the present strength and the Board of Trustees shall have the powers to co-opt additional trustees.

The Trust shall have permanent office having seal and symbol of its own and shall continue from generation to generation upholding the objects and aims for which Trust is created.

PATRONS/LIFE MEMBERS

The Board of Trustees may recognize certain persons as Patrons of the Trust or Life members considering their

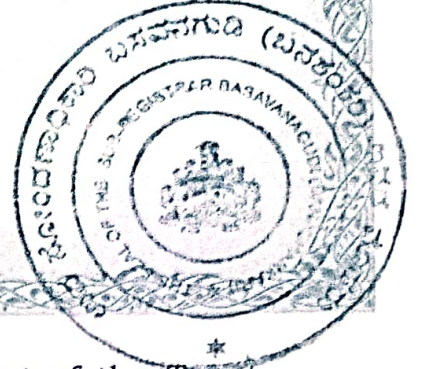

contribution for the development and management of the Trust and its activities. The Trust may also have a Management Committee/ees which may consist of Trustees and other persons for taking advice and guidance regarding Management of Institutions run and managed by the Trust.

The terms and conditions of appointment, duration of office and removal of Management Committee or its members shall vest with the Trustees. Similarly, establishing or forming of Management Committee and abolishing of such Management Committees shall also vest with the Trustees of the Trust.

VACANCY NOT TO INVALIDATE PROCEEDINGS:

Any vacancy in the Board of Trustees and / or illegality in the appointment of trustees or their proceedings shall not invalidate any prior act on decision of the Board.

MANAGING TRUSTEE:

The first Managing Trustee shall be the author. He and the succeeding Managing Trustee NANDITHA.B.G. shall hold the office of the Managing trustee for the duration of their respective lives, and the trustees for the time being shall appoint one amongst themselves as the Managing trustee, on the occurrence of the vacancy in the office of Managing Trustee. The office of the Managing Trustee shall be expeditiously filled and not later than three months from the date of which the office would fall vacant.

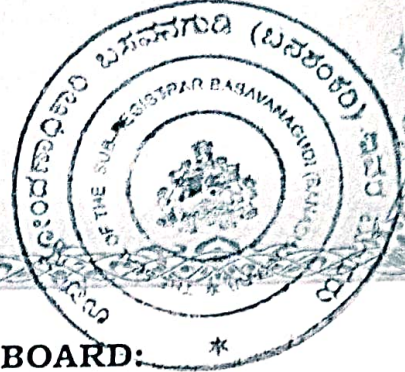

TRUST ADMINISTRATION AND POWER OF THE BOARD: *

The board of Trustees shall have full power and authority to administer the trust, its properties and affairs and to do all acts, deeds and things which are calculated to fulfill the performance of the objects for which the trust is established. Without prejudice to the generality of the foregoing the Board shall have the following power and authority for the purpose of the trust.

- To apply the whole or any part of the Trust property or funds i.e., income or capital first towards payment of the expenses of the trust or towards all or any of the purposes of the trust.
- To open one or more Bank Accounts and operate the same.
- To invest, in its absolute discretion, the funds of the trust in any manner they deem fit; in the modes specified under provisions of section 13(1) (d) read with section 13(5) of the Income Tax act:
- To sell, mortgage, grant or lease, hire and otherwise alienate all the properties of the trust, in its discretion for adequate consideration.
- To execute power of attorney or attorneys to any person for the purpose of executing or managing the whole or part of the trust, subject however the delegation shall only be for the purpose of convenience and advantages of administering the properties of the trust and for the attainment of the objects of the trust.
- To borrow money with or without security and to repay the same.
- To receive, collect and enforce recovery of all monies due or payable to the trust and grant necessary receipts and discharges thereof.
- To receive voluntary contribution from any person or persons whomsoever by donation, legacy and gifts, to hold the same upon trust for the objects and subject to the powers, provisions and stipulations setout herein.
- To compromise, settle or compound all or any debts, claims, outstanding, accounts, disputes, demands, actions, suits and

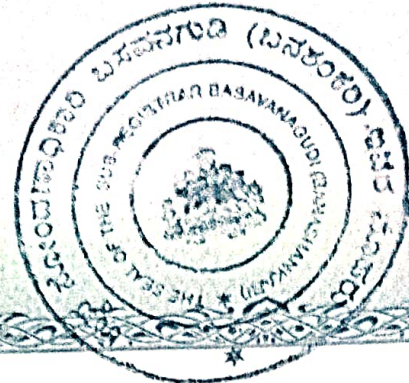

proceedings whatsoever or refer the same to arbitration as the case may be.

- j) To appoint, suspend or otherwise deal with the staff employed for the administration of the trust or in carrying out the objects of the trust and to terminate the services of the staff.
- k) To have all powers, ancillary and incidental to effectively carryout the objects of the trust;
- l) To grant, subscriptions and donations in any form to such public charitable institutions whose objects and purpose are similar to those of these presents;
- m) To delegate all or any its powers to the Managing Trustee/Chairman;
- n) The Board of trustees may constitute separate Governing Councils for each of its projects/Institutions for their smooth and efficient functioning consisting of not more than 9 members in which there shall be a minimum 1/3 members from the Board of trustees for each of the projects or institutions undertaken by it separately. The trust shall also nominate the chairman of the governing council for a period of three years, and the quorum for the meetings shall be 1/3 of its members. The Governing council may meet as often as they could depending upon the need and urgency. However, the activities conducted by the Governing Councils require the approval and ratification by the Board of trustees. The Board of Trustees may delegate the powers to operate the Bank Accounts of the respective institutions or projects to any of the two members who shall operate jointly but one of them should be a trustee member or both of them trustees members, and one of the trustees shall be ex-officio Secretary for each of the governing councils. The Board of Trustees have the power to remove any member of the governing councils, such of those who are not acting in the interests and welfare of trust by a simple majority.

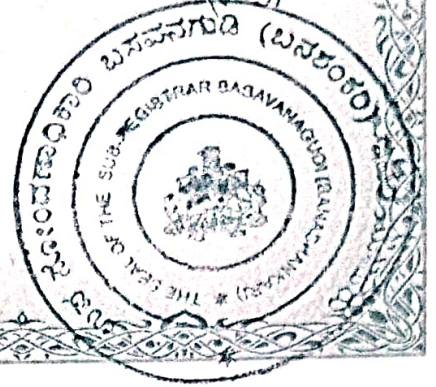

PROCEEDINGS OF THE BOARD:

The board may meet as often as may be necessary for efficient conduct of the trust. But at least once in 3 months for transacting the business by giving seven days clear notice. The board may take decision on any question either at meetings or by circulation of papers. All the decisions of the trustees shall be by majority vote. The Managing trustee have a casting vote incase of equality of votes.

BOARD'S POWER TO FRAME RULES:

The Board shall have full authority and power to make, alter and rescind Rules and Regulations for the management's and administration of the trust. However, no Rule, amendments shall be made which may be proved to be repugnant to provision of Sections 2(15), 11 to 13 and 80 of the Income Tax Act, 1961.

The Board of Trustees shall have the power to amend this deed of Trust, as the situation demands.

DUTIES AND RESPONSIBILITES OF BOARD OF TRUSTEES:

a) CHAIRMAN

1. **Chairman** of Board of Trustees shall always preside over the meeting of Board of Trustees.
2. **The** Chairman shall supervise and exercise proper control over the general administration of the Trust and will seek advice from the Board of Trustees of the committees and sub-committees.
3. **Every** question or/subject coming before the Board of Trustees meeting shall be decided by majority votes of Trustees.

- iii. The Secretary shall be responsible for maintaining all the records and documents concerning statutory, legal and procedural requirements.

1. The Vice-Chairman shall perform such duties which are assigned to him by the Chairman of the Board of Trustees.
2. In the absence of the Chairman, the Vice-Chairman shall preside over the meeting of Board of Trustees.

c) SECRETARY:

- i. The Secretary shall be responsible for the safe custody of all the properties and records relating to the administration and maintenance of the Trust properties, and the regular and statutory records of all meetings and proceedings.
- ii. In all legal proceedings, the Secretary is entitled to defend the Trust and he/she is entitled to represent on behalf of the Trust and may take appropriate legal aid when necessary, subject to the approval of the Board of Trustees.
- iii. The Secretary shall be responsible for maintaining all the records and documents concerning statutory, legal and procedural requirements.

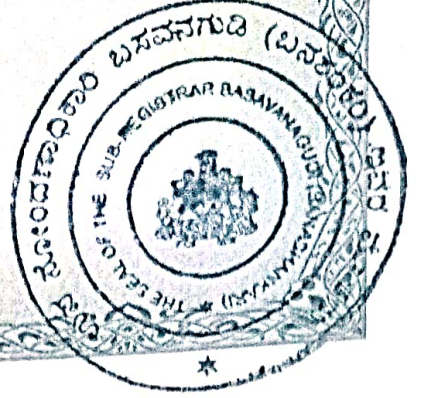

MINUTES, ACCOUNTS AND AUDIT:

The board shall maintain true and correct accounts of the trust and a correct record of their deliberations and shall get the accounts duly audited by a chartered Accountant.

NO BREACH OF TRUST BY TRUSTEES:

No trustee shall commit any act or breach of trust of the trust fund or property or cause any loss to or fraud in the administration of the trust fund or property.

INDEMNITY:

A trustee shall not be responsible for any act done by him in good faith in the course of administration of the trust fund property.

NO REMUNERATION TO TRUSTEES:

No Trustee shall claim remuneration for services rendered to the trust but may reimburse himself for expenses incurred by him in the administration of the trust.

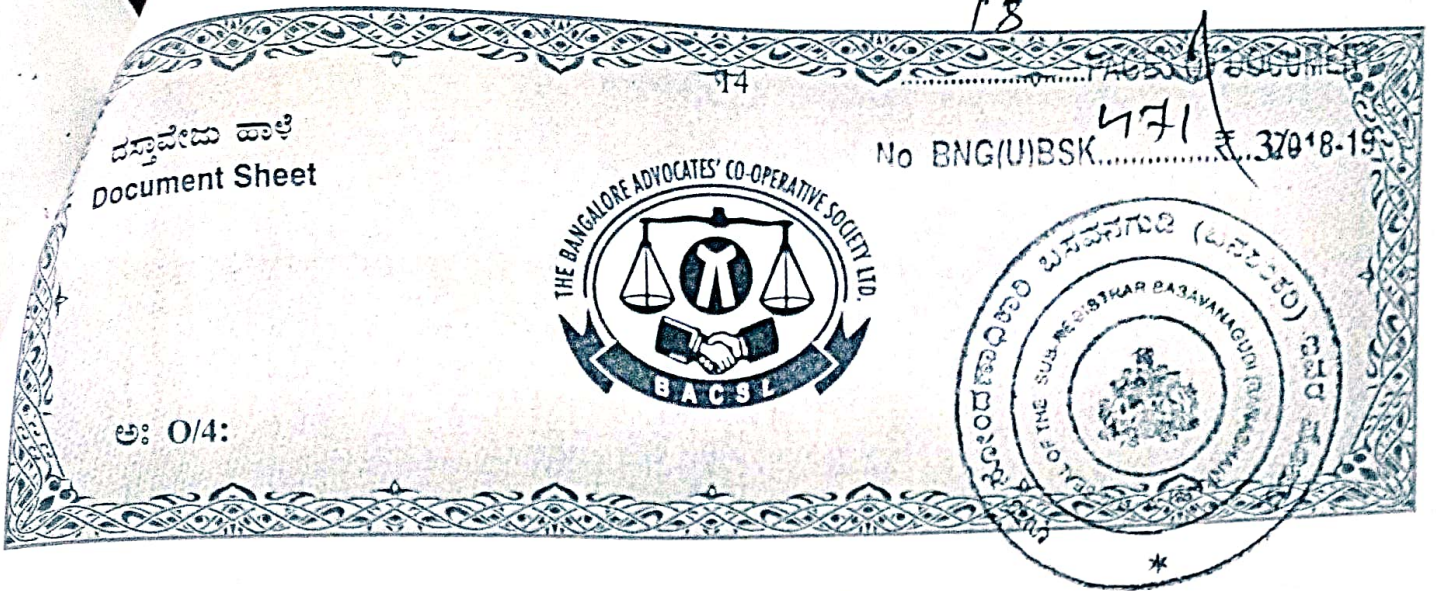

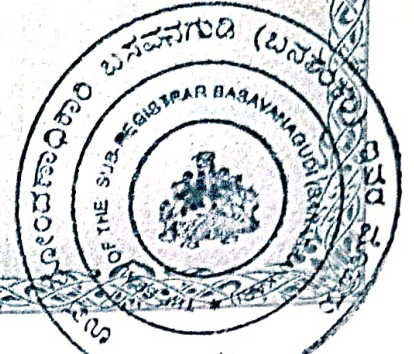
