According to your request, Fire Advisory letter was issued on dated: 25.07.2025 from the Fire and Emergency services Department to the M/S. B.G.S. Bloom Field School Building with 17.22 mt height Ground Floor and 04 Floor building situated at No. 38, 6th Cross, 3rd Block, Tyagarajanagara, Basavanagudi, Bangalore City.

In the Ref (2) your letter, you had mentioned that installation of Fire extinguishing Equipment was completed and requested to issue complete letter from Fire and Emergency Service Department.

According to your request, on dated 17.09.2025 Regional Fire Officer, Bangalore South Zone, Karnataka Fire and Emergency Services had examined the Educational Building situated at No: 38, 6th Cross, 3rd Block, tyagarajanagar, Basavanagudi, Bangalore City and mentioned that Fire protection and control and Installation of Fire extinguishing Equipment and protective measures were completely implemented in the Education Building as mentioned in the Advisory Letter issued by the Fire and Emergency Service Department and at the present Building only fire fighting Training is due to

the Employees / Staff of this building and after the complete letter of the present building it will be possible to provide Fire Fighting Training to the employees/ staff of this building.

Therefore, Protective measures should be strictly followed in the M/S. B.G.S. Bloom field school with 17.22 metre height ground floor and 04 floors situated at No: 38, 6th Cross, 3rd Block, Tyagarajnagar, Basavanagudi, Bangalore city as mentioned in the advisory letter issued by the Fire and Emergency Services Department dated 25.07.2025. Also in your cover letter you are agreed to keep Fire Extinguishing Equipment in a good state. It is hereby issuing complete letter by the Fire and Emergency Services Department with a condition that Fire and Emergency Services Department with a condition that Fire Extinguishing Instruments to be kept in a good condition and 40% employees / staff of the building to be given training in Fire Control and measures at the R.A. Mudkoo Fire and Emergency services academy, Bangalore with 3 months.

This Complete letter will be in force from the date of delivery till the next two years, letter is is to be renewed.

Also if at any stage, if found that fire prevention and Fire extinguishing are not in a good condition as recommended by the Department or if protective measures are not followed correctly or according to law in the open area left in present building, if additional construction are constructed or if any type of temporary / permanent obstacles created them this complete letter will be cancelled and it is mentioned that in such cases legal action will be taken.
